

Fugitive dust is controlled by a C&W Model CP900 central dust collector and shroud.

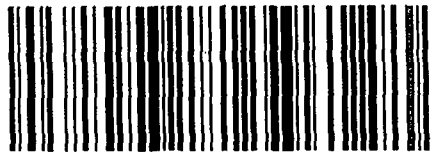

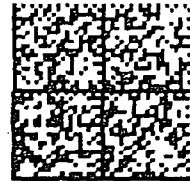

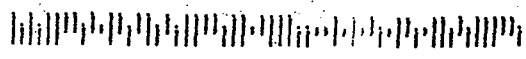
