

The central dust collector is a ground-mounted unit manufactured by DCS, Model RA 1400, serial number 1-069.

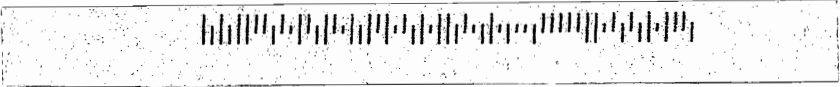
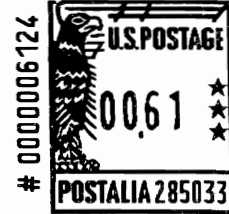
