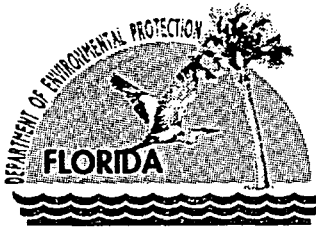

The Department has received the Title V General Permit Notification Form for the halogenated solvent degreasers facility that you submitted on March 8, 2006.


