The Department has received the Title V General Permit Notification Form for the dry cleaning facility that you submitted on September 3, 1996.



Thank you for your note asking the Division of Air Resource Management to change the name of the Responsible Official for Nu-Look 1 Hr Cleaners #56 (#0112296) from Sang Park to Eunae Park. The division received your request on January 26.
