



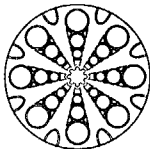

MERRITT'S BOAT AND ENGINE WORKS IS A BOAT BUILDING AND REPAIR FACILITY COMPOSED OF SEVERAL BUILDINGS. SURFACE COATING OPERATIONS TAKE PLACE IN TWO (2) BUILDINGS. BOATS AND BOAT PARTS ARE SPRAY PAINTED USING HAND-HELD DEVICES. FACILITIES CONTAIN UPBLAST EXHAUST FANS AND FILTER RACKS TO CONTROL AIR POLLUTANT EMISSIONS. SMALL PARTS ARE PAINTED IN ONE BUILDING. A SECOND, THREE-WALLED, OPEN-FACED BUILDING WITH FILTERS ALONG ONE WALL IS USED FOR BOAT SPRAY PAINTING.

RE-REGISTRATION IS FOR THE CONSTRUCTION OF A NEW 4,100 S.F. BUILDING FOR SPRAY PAINTING OF LARGER BOATS. PROCESSES, EQUIPMENT, AND BUILDING WILL MATCH EXISTING THREE-WALLED, OPEN-FACED SPRAY BOOTH.

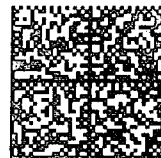
