Thank you for your e-mail requesting withdrawal of the Air General Permit Registration Form for a Nonmetallic Mineral Processing Plant to be located at 19820 Sylvan Pass, Pembroke Pines, Broward County, Florida 33332, with a proposed start date of January 2010.

I have already processed your request for withdrawal.

Per recent conversations between Ms. Wooley of your office and myself, it is my understanding that the purpose for your withdrawal of the registration form is that you have not yet taken possession of the actual crusher unit and therefore could not provide the required equipment data as requested in the registration form.. As the result your application would be considered incomplete since that information is critical in demonstrating eligibility for use of the air general permit according to the rules.

As you have indicated, you may submit a new registration form at a date future when you have possession of the supporting equipment data requested.
