

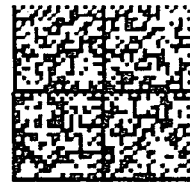
This facility has an aggregate loading system consisting of 2 aggregate hoppers, one sand hopper, and a 10 cubic yard weigh hopper. This facility has one cement silo and one fly ash silo (both with baghouses) which empty into the weigh hopper from overhead. This facility combines rock, sand, water and cement to make ready mixed concrete. The mixture is loaded into a ready mix truck and transported to job sites. The plant operates 5.5 days a week. The plant is in operation based on market demand.

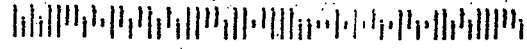
