

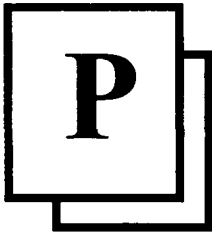
Description of Facility

The batch plant is a Belgrade 12 yard concrete batch plant. It consists of the following components:

- 1) Belgrade 850 barrel split compartment silo, for cement and flyash materials
- 2) Two Belgrade dust collectors (Belle style dust house, 225 sq ft of bag area for up to 675 CFM of pneumatically conveyed cement) The dust house has a 3.0:1.0 air to cloth ratio.
- 3) Control equipment located on top of the silos which are vented directly to the control equipment
- 4) ConECo Pulse Jet 980 Dust Collector

The typical loading rate is approximately 25 tons/hour.
