Please review the following and upon approval, attach this letter as an addendum to the above referenced renewal application.

Description of Facility:

- Energenics Corporation purchases fire retardant type resin, gel coat, and Hybon glass string from a third party vendor to fabricate large filter housings for our products to ship to our customers who are commercial laundry facilities. We house the production process in a separate building from our assembly production and offices. The building consists of 2 bays and small storage area that are divided and do not have access to each other except through the door openings in the front of the building. The bays have garage door openings and the storage area has a "man" door opening. During the application process, the bay doors are open and industrial fans are used for proper ventilation.
- For the production, Energenics uses Magnum Venus's gel spray system (model: F-FIT-G-WM-APS-20-R) with gel gun (model: ATG-FIT) and resin and glass chopper systems (model: F-FIT-C-WM-APS-6-R) with chopper gun ((model: ATC-FIT). The fiberglass team then sprays the gel and resin/chop on pre-made molds.

Good morning Mr. Hutterly,

I am in receipt of the subject item Reinforced Polyester Resin Operations Air General Permit Registration Form (see attached pdf file), which you have submitted for the purpose of renewal of your entitlement to operate.

There are two purposes for my e-mail.

1. On page ten (10) of the form, under the block heading "Description of Facility", the following information is requested:

"Below, or as an attachment to this form, provide a description of the reinforced polyester resin operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. Describe all air pollutant-emitting processes and equipment at the facility, and identify any air pollution control measures or equipment used."

The response, as provided on your form, "Fiberglass used to produce industrial laundry filtration equipment.", did not adequately describe your reinforced polyester resin operation. In order to demonstrate eligibility for this air general permit, 1) a short description of the process, and 2) equipment identification (e.g. – use of chopper guns, hand lay-up, mold, use of gel-coat, spray booth, filter systems, etc.) would be in order and would provide me the opportunity to continue and complete the review for renewal of your entitlement.
