The facility operates two Ready- Mixed Concrete Batch Plants (1-A & 1-B) at a combined rate of 98 CY/HR.

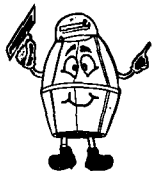
The Silo (S-3) is being replaced by a new split silo (S/S #3) provided with individual baghouses (B/H #3-1 and B/H #3-2). The existing central dust collector (C/DC #1) continues to service also the loading points of the new silo.

The new silo is manufactured by Bellgrade and has a capacity of 500 bbl per section.

The stored materials are Portland Cement and slag,

The new baghouses are pulse-jet operated; 300 ft² filtering area each ; and +99% efficiency.

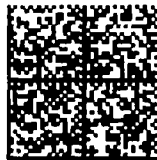
