

Fuel Consumption

The Northwest Wellfield has electric motor-driven pumps that convey raw water to the Hialeah and Preston Water Treatment Plants for treatment and distribution to the public potable water supply system.

Four 1,835-hp Waukesha Model L7042-GSI natural gas-fueled engines, each driving a 1,300-kilowatt electrical generator, are provided to meet the wellfield's standby and emergency power requirements.

Fuel usage is monitored by the natural gas fuel meter readings and invoices from the natural gas service provider that directly fuels the bank of engines.

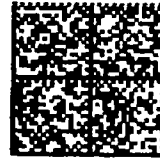

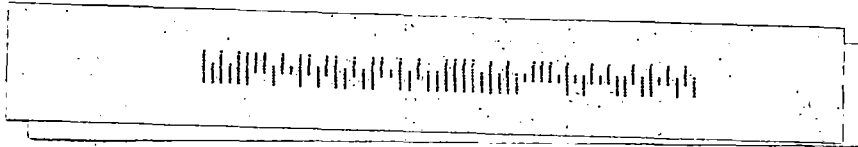
