

### Fuel Consumption

Pump Station No. 536 has electric motor-driven pumps that convey raw sewage to the wastewater treatment plants for final treatment and disposal.

Two 1,835-hp Waukesha Model L7042-GSI natural gas-fueled engines, each driving a 1,300-kilowatt electrical generator, are provided to meet the pump station's standby and emergency power requirements.

Fuel usage is monitored by the natural gas fuel meter readings and invoices from the natural gas service provider that directly fuels the bank of engines.

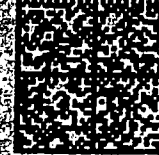
