

Ready-mix concrete plant producing 185 cubic yards/hour — 12 hours/day; 6 day/week; 52 weeks/year — emissions from cement/flyash/PenCem storage silos, weigh hopper, & RMC truck loadout controlled by a central dust collector and three baghouses.

EU 01

C & W Model CP-900

Dust collector controlling weigh hopper and mixer truck loadout spout. the collector has 12 - 8" x 78" cartridges with 1069 sq.ft. of filtration area and CFM of 5,000 for an air to cloth ratio of 4.7(ACFM/sq.ft.). The baghouse has a pulse jet with timer for a cartridge cleaning mechanism.

EU 02 and 03

C&W Model CP-340

Two (2) top of silo mounted baghouses. One controlling each compartment of a cement/PenCem split storage silo. Each collector has 9 - 8" x 39" cartridges with 342 total filtration area and CFM of 1,800 for an air to cloth ratio of 5.3(ACFM/ft²). Bags are cleaned via pulse jet with timer.

EU 04

C&W Model CP-310-478

One (1) silo top mounted baghouse controlling a single stand alone flyash storage silo. The collector has 4 - 8" x 78" cartridges with 304 total filtration area and CFM of 1,600 for an air to cloth ratio of 5.3(ACFM/sq.ft.). Bags are cleaned via pulse jet with timer.

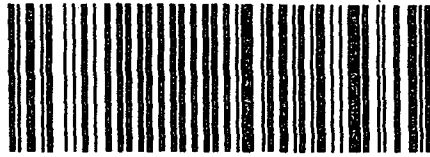

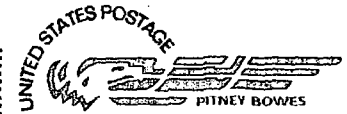
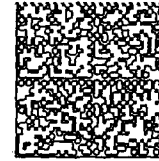
