

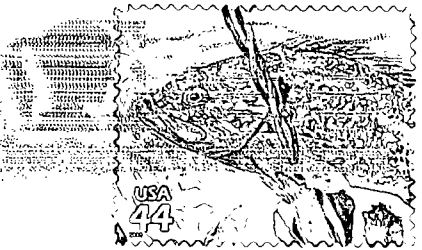
Newcastle Shipyards LLC. specializing in new yacht construction, in steel and aluminum..

The bulk of all steel supplied to the yard is pre-blasted and primed by the manufacturer and therefore only the weld areas require grinding and sandblasting before finish coatings are applied. Most primers and top coats are two-part polyurethanes applied with airless paint sprayers and conventional 2 gallon spray pot. Some latex paints are used in appropriate areas.. Blast medium is environmentally friendly Starblast.

VOC's are to be monitored to ensure compliance with the air permit.
