- ✓ EU02 - Cement Silo #2 - E DC on N side, serial number unknown
- ✓ EU03 - Load out/weigh hopper - CDC, serial number unknown
- EU04 - Flyash - W DC on S side, serial number unknown
- EU05 - Slag - E DC on S side, serial number unknown
