

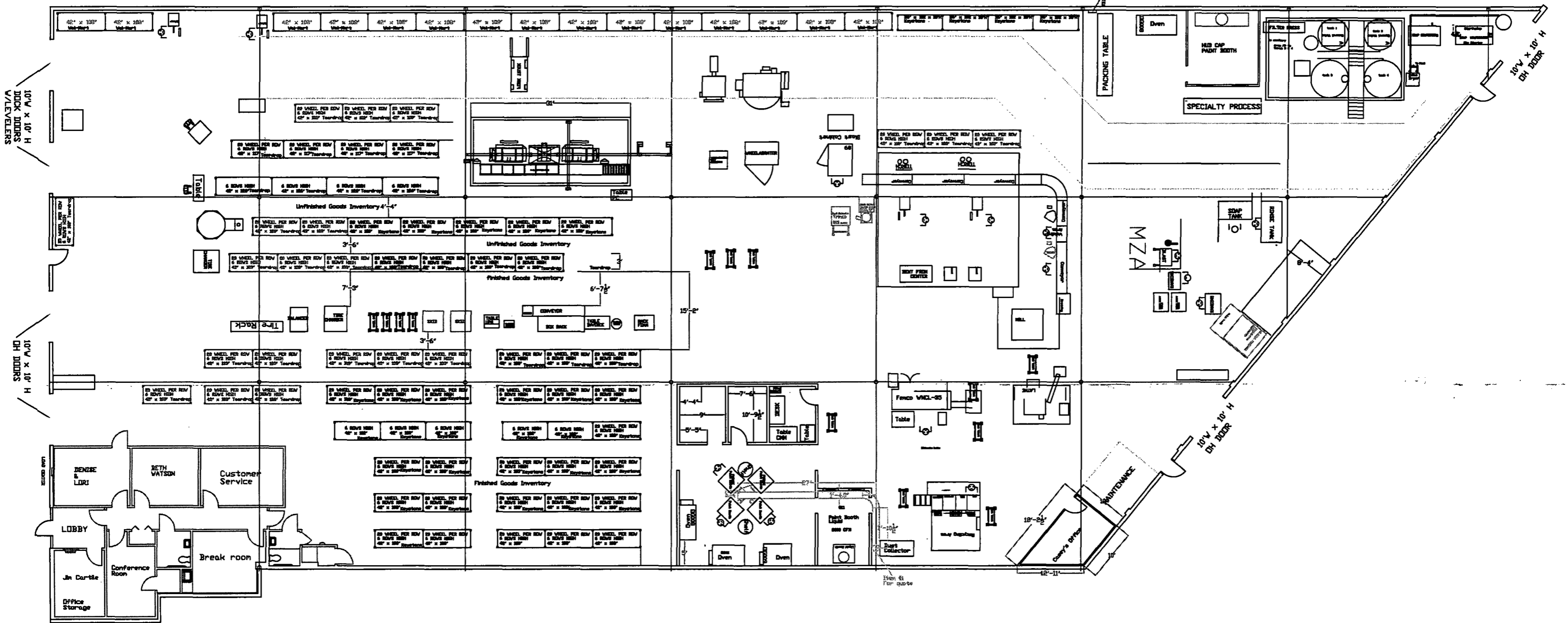
Wheels are received, identified and logged into our system. Wheels are then spun on manual fixtures to check the wheels trueness. The wheels are first cleaned mechanical and then chemically stripped. This stripper solution contains VOC, and releases 19.8 lb/day. Following this the wheels are then mechanically cleaned one more time. Next the wheels are repaired (straightened, dents removed etc.) via hand tools and presses, welding. The wheels are then prepared for painting (liquid or powder coat) and powdered clear coat. The liquid paint process for wheels emit up to 3.72 lb VOC/day.

Wheel covers are received, identified and logged into our system. Wheel covers are cleaned (soap and water), sanded and prepared for painting. The wheel cover painting process emits up to 3.65 lb VOC/day

The total VOC emissions are 27.2 lb/day for the plant.

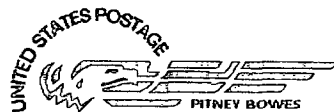
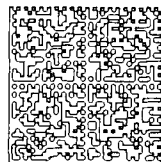
