

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty (30) days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after five (5) years. Therefore, a new registration form must be received no later than five (5) years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.



Description of Reasonable Precautions

This facility is provided with an extensive stormwater/wastewater drainage system, which is designed to flush particulate matter from the paved yard and entrance drive. This keeps the paving cleaner, substantially reducing fugitive emissions. Aggregate stockpiles in the yard are stored on paved surfaces and kept watered, partly for quality control and partly to reduce potential emissions from these materials. Unused concrete which is brought back to the site is stored in a concrete-walled washout structure, which reduces the area needed to dry the material, while keeping it out of the main traffic pattern, where it would generate additional fugitive emissions.

Description of Facility

Below, or as an attachment to this form, provide a description of the concrete batching plant operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. Ready-Mix Concrete Batching Facility, which utilizes cement, flyash, slag and aggregate materials to produce ready-mix concrete. Dust emissions generated during the filling of the plant's silos or loading of concrete mixer trucks are controlled by cartridge dust collectors. Details of these emissions units (EU's) are as follows:

- ✓ EU-01 - Cement silo compartment no. 1 (with a C. & W. Dust Systems Model CP-305-839 cartridge dust collector).
- ✓ EU-02 - Cement silo compartment no. 2 (with a C. & W. Dust Systems Model CP-305-839 cartridge dust collector).
- ✓ EU-03 - Flyash/slag silo compartment no. 1 (with a C. & W. Dust Systems Model CP-305-839 cartridge dust collector).
- ✓ EU-04 - Flyash/slag silo compartment no. 2 (with a C. & W. Dust Systems Model CP-305-839 cartridge dust collector).
- ✓ EU-05 - Cement weigh hopper (with a C. & W. Dust Systems Model CP-70-419 cartridge batcher vent).
- ✓ EU-06 - Concrete mixer truck loadout (with a C. & W. Dust Systems Model CP-1220-1678 central cartridge dust collector).
