

- Roads at the front of the facility will be paved and in the back of the facility will be a pressed hard milling surface.
- Roads and yard areas will be cleaned as needed to prevent dust from entering the atmosphere.
- All particulate matter will be removed during cleaning process.
- Parking areas paved.
- Stock piles will be kept under roof and planning for "just-in-time delivery" to the plant.
- Storage yard paved.
- Dust suppressants will be used in areas where particulate matter reaches the ground floor driving surface.

Description of Facility

- Rock and sand will be delivered to the facility and placed on hopper and conveyor system that will deliver them to an "Aggs silo" that will store these Aggs under roof until they are used by the batching system. Rock and sand are delivered to the mixer via a contained system (under roof as well) which delivers them to the enclosed mixers.

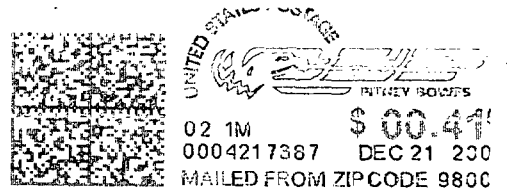
- ~~FA~~ Fine Aggs - Fly Ash / Cement

- Ash & cement will be delivered to the facility and blown in to storage silos which are totally closed with a filter system to capture any Fine Aggs before it would enter the atmosphere. Fine Aggs are delivered to the mixer via a totally closed system.

- Mixing

- The Aggs (Rock, sand, cem, FA) are delivered to the enclosed mixer. During delivery and mixing all dust is contained in the mixers via filters.
