Alan, and Caroline

I am in need your help.

I am in the process of renewing an AG registration (AIRS ID# 0694842-004) recently submitted as the result of an ownership change (SUPERIOR CONCRETE SERVICES CORP was sold to FLORIDA BUILDING MATERIALS INC.)

As I was beginning the process I discovered that a duplicate entitlement, AIRS ID# 0694845-001 had been issued (09/19/2005) by your office for the same facility which at that time had already been entitled under AIRS ID# 0694842-002. Apparently, when it was discovered, ID# 0694845-001 project permit data was transferred to ID# 0694842 as project #003, sometime after 02/23/2006 and was chronologically displaced by project ID# 0694842-002, the active project for this facility at that time and currently.

After discussing with Yi Zhu, the following situations should be corrected and they can be accomplished one of two ways.

1) The first alternative (**most desirable**) solution would be to transfer all Compliance Activity including VE test results from #0694845 to 0694842 **and then Yi will remove/delete 0694845 completely from the system**. It appears that VE test and/or scheduling data is still being entered in 0694845's Compliance Activity fields even when no permit exists. For example in 0694845 it appears that a VE was scheduled for 03/24/09 and it would be best to eliminate any possibility of entering any data in the wrong facility ID. According to the Compliance Activity in 0694842 the last VE was scheduled for 09/18/07.

2) The second alternative (**least desirable**) solution would be to first change the Facility Status of 0694845 to INACTIVE (0694845 should have been made INACTIVE at the time the permit/project data was transferred to 0694842), and then cross-reference the other facility in both Facility Screens

I am currently in the thirty (30) day review window for this facility (0694842-004) beginning March 30, 2009 and I would appreciate your help in correcting this situation as soon as possible.

After the corrections are made I will be inputting more detailed EU data for this facility in ARMS, as little EU or EP data currently exists. I will need to enter that data before the end of the thirty (30) day review period.
