
This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on October 30, 2008. We have assigned ARMS No. 0694846-002 to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty (30) days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after five (5) years. Therefore, a new registration form must be received no later than five (5) years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.

Description of Facility

Please note that this application for an Air General Permit, is for the modification of the Leesburg concrete batch plant. This facility maintains the manufacturing process of brick. C & D Thin Pavers and Copping's Largo facility ID# 7775198 sells the brick at retail. The Leesburg facility will be adding another silo to the concrete batch plant from the relocatable plant in Largo, Florida. Leesburg currently has one silo in operation. The description of this emission unit is as follows:

Emissions Unit #1:

WAM Silo Top seven (7) cartridge (Spun-bound Polyester) with a total cartridge area of 264 square feet and a maximum of 1500 ACFM. The Spun-bound Polyester cartridge fabric weight dimensions are as follows: Fabric weight – eight (8) ounces, Weave – ten (10) micron, Finish – coated, and Maximum Fabric Temperature – 175 oF. The efficiency of the WAM Silo Top Baghouse is 98-99.9 % with an air to cloth ratio of six to one (6:1). The method of the baghouse cartridge cleaning is by pulse jet and is vented. The operating pressure drop is: Minimum four (4) inches of water and Maximum of eight (8) inches of water. The particulate grain loading is: Inlet – 30 grains/scf and Outlet - .01 grains/scf (cement).

The description of the silo that will be added from the relocatable Largo facility to the Leesburg facility is as follows:

Emissions Unit #2:

Belgrade 200 Barrel low profile portable cement silo (8'6" wide X 13'6" tall X 26' long). The emissions are controlled by a Belgrade baghouse with 150 square foot of filtration. The filter has 18 bags with material made of PE 37 100% polyester. The filtering velocity is 2.5 (acfm/sq ft) of cloth.

Considering Leesburg has one emissions unit active at this time, it should be emissions unit #001 in the permit, and the new silo should be emissions unit #002.
