

001 N
006 S The northwestern most, shortest silo contains slag on the north side and flyash on the south side. Each compartment is controlled by a C&W Model CP-LPR-6-S-FS baghouse and the serial number is unknown.

003 The weighscale and truck batching operations are controlled by a C&W Model CP-1220 central dust collector and the serial number is unknown.
