

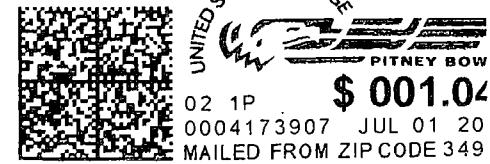

All six tanks are double wall underground tanks. They are all equipped with submerged filling drop tubes. All tanks are equipped with vapor recovery adaptors. The loading rack has top fill loading arms. The rack does not have a vapor recovery system for filling trucks or trailers.
