

For your information, authority to operate pursuant to Rule 62-210.310 expires after 5 years. Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.



Description of Facility

Below, or as an attachment to this form, provide a description of the nonmetallic mineral processing operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. Describe all air pollutant-emitting processes and equipment at the facility, and identify any air pollution control measures or equipment used.

This is a permit registration for a Kolberg Pioneer 2007 Model 5260 (SN 408139) Non Metallic Mineral Crusher with a design capacity of 350 tons/hr. This unit is equipped with three spray bars that provide water mist at the discharge opening for dust control. The crushed stone is being conveyed to a 2007 Model Kolberg Pioneer 8x20 (SN 408147) screen deck that is equipped with fifteen spray bars for washing the processed stone. Oversized material is then directed to a 2007 Model Kolberg Pioneer 4250 (SN 408142) Non Metallic Mineral Crusher with a design capacity of 200 tons/hour. This unit is fed wet stone from the wash screen but is also equipped with three spray bars in the event that water mist is required for additional dust control. When all of the aggregate is properly sized, it is conveyed to a 2008 Model Deister 8x20 screen deck (SN 2000740) for additional washing and rinsing. This screen is also equipped with fifteen spray bars. All of the finished aggregate products will be conveyed to stockpiles by utilization of seven radial staking conveyors. The plant will be powered by a 1000 Kw generator, a 125 Kw generator and the water pump will be direct diesel drive utilizing a 350 hp engine.

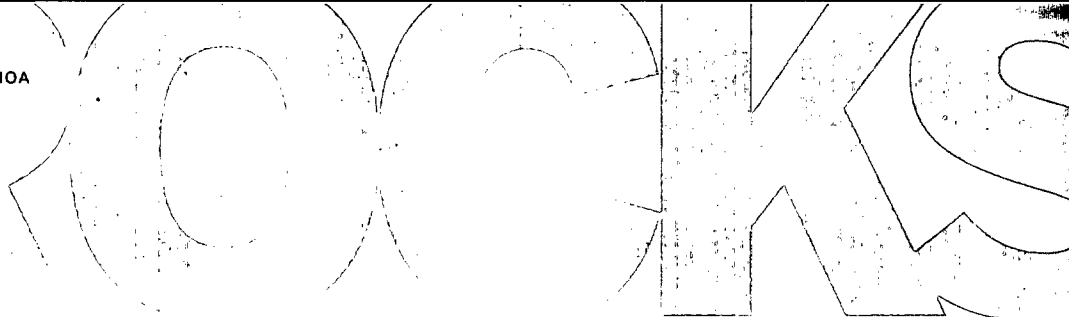

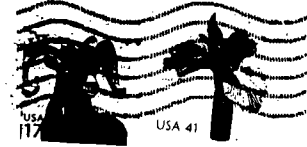
