Ft. Myers Toyota / Ft. Myers Scion is an automobile dealership that performs repairs and bodywork on automobiles. Bodywork is performed in the collision center which has two Garmat 3000 downdraft paint booths, one 8 foot by 14 foot Garmat paint mix room and one Garmat parts jamming booth (model 10812) all located under one roof. Viledon vil 100-010 filters are used in the paint booths and spray guns are high volume low pressure (HVLP) IWATA LPH 400. Air pollutants are emitted during painting of vehicles, sanding and paint removal and cleaning of equipment. Air emissions are minimized through the use of high-efficiency overhead and downdraft floor filters in the paint booths, HVLP spray guns and though the use of water-based paints and gun cleaners.


