Each of these plants are about 30-35 years old and have not been modified much over the years. There are no central dust collectors and each of the plants has a truck loading or batching station. They control fugitive emissions using a water-spray misting bar above the truck loading area and the cement scale vents into the truck being loaded.

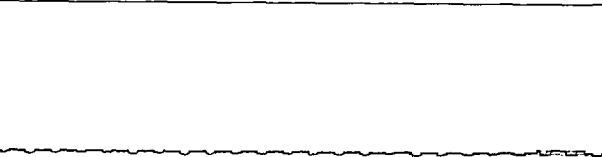
