Nobility Homes produces manufactured homes at their existing facility located in Ocala, Florida. Several different types of glues and adhesives are used in the production process. Solvents and thinners are also used in the process for cleanup. A small amount of aerosol paint is used to paint small wall anchors in the homes.

Total potential emissions for the facility are less than 10 tons per year (TPY) of any hazardous air pollutant (HAP), 25 TPY of total HAPs, and 100 TPY of any regulated pollutant.

All emission units at the facility would be covered by this Air General Permit, except for the two small fuel storage tanks, which are exempt from permitting under Rule 62-210. 300(3)(a)19, F.A.C.

The materials (adhesives, glues, aerosol paints) applied at the Ocala facility are classified under the definition for coatings under Rule 62-210.200, F.A.C.: "The application of a protective, decorative, or functional film to a surface."

Helpful Definitions

- "Coating" The application of a protective, decorative, or functional film to a surface.
- "Department" or "DEP" The State of Florida Department of Environmental Protection.
- **"Emissions Unit"** Any part or activity of a facility that emits or has the potential to emit any air pollutant.
- "Facility" All of the emissions units which are located on one or more contiguous or adjacent properties, and which are under the control of the same person (or persons under common control).
- "Owner" or "Operator" Any person or entity who or which owns, leases, operates, controls or supervises an emissions unit or facility.
