The Department has received the Title V General Permit Notification Form for the dry cleaning facility that you submitted on August 31, 2007.



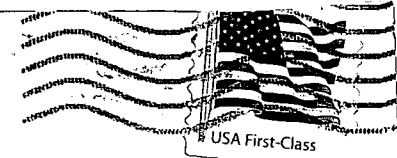

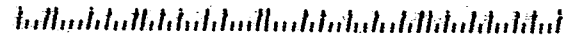

Dear Ms Bowman,

When planning to inspect dry cleaners in Ocala, I discovered an inconstantly within the GPCI/ARMS data base. It appears that the old information for ARMS ID 0830108 has been changed and when I checked my local documents I could not locate the permit application document indicating the change. I then went out into the field and talked to the owner of the dry cleaner to see if I could find out what happened. It appears that the owner of Rick's Cleaners located at 2211 W silver Springs Blvd purchased S-Curve Cleaners located at 9 SW 10<sup>th</sup> Street, Ocala, Florida in September of 2007 and sent in a permit application to change the permit into his name. It appears that somehow the permit application had been attached to his original permit number. Below is the correct facility information:
