Description of Facility

This facility has a ready mix plant and a block plant. The ready mix plant is a McNeilus Model MTM Batch Master Plant, serial number 693-4195. The plant includes aggregate bins, aggregate conveyor system, one cement silo, one flyash silo and a weighted bridge for mixing with aggregate. The block plant includes one cement silo and conveyor system.

Ready Mix Plant:

The cement silo is the southern most silo. It is a 600 barrel silo and has a McNeilus baghouse (serial #4216) mounted on the top of the silo. The flyash silo is the northen most silo. It is a 400 barrel silo with a McNeilus baghouse (serial #4216) mounted on top of the silo. There is a central dust collector that controls the emissions from mixing and truck batching operations. It also a McNeilus, serial #4216.

Block Plant:

The block plant has one 500 barrel cement silo that is controlled by a silotop WAM cartridge dust collector, model R01. The serial number is unknown for this unit.
