

This facility has two silos, aggregate and sand storage bins and hoppers, conveying equipment and mixer trucks.

The northern most silo contains slag and is vented to the central dust collector to control the emissions from silo loading.

The southern most silo contains cement and is controlled by a C&W model CP-LPR-6, serial number 8671 baghouse.

The truck batching operation is controlled by a ground-mounted central dust collector that is a C&W model RA-120, serial number 8165.
