The fly ash silo is about 1960 vintage Merit, with a capacity of 60 tons of Type F ash, using four (4) 72" x 20" cylindrical bags with an approximate area of 500 sf.

Future emissions - spray with small droplet sized sprayer heads, which promotes a total blanket around the load hopper.


