There is a ground-mounted central dust collector that controls emissions from both the slag and cement silo and the truck batching operations. The central dust collector is a C&W Model RA 140 and the serial number is unknown.

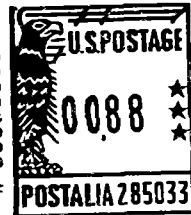
