



The facility will consist of an office an truck mainteance shop, tarp covered sand storage stockpiles, cement storage silo and gunite batch trucks.

Cement is stored in the silo, to be loaded into the covered bin of a batch truck. Gunite trucks are then driven to construction locatons and cement/sand is off loaded as part of swimming pool construction

Emissions from the silo loading operation are controlled by a silo mounted Belgrade stell dust collector containing polyester filter bags. Typical loading rate is 25 tons per hour.




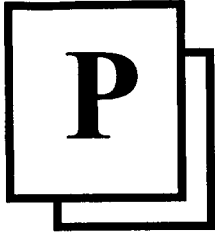
