

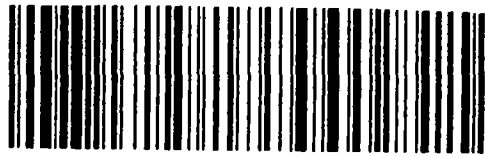

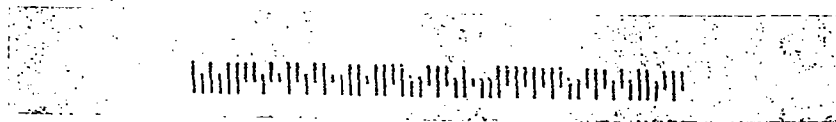

The highest 12-month fuel usage average was during 2005 where 10,308 gallons of diesel fuel was used for the year. This was due to Hurricane Wilma when the emergency generators ran for 24-hours during a 5-day period.
