

Material Usage Rate Answer- The highest 12 month period total quantity used was 63,200 pounds of styrene-containing materials. This occurred in calendar year 2007. Our current usage is dramatically less.

Description of Facility Answer- Production of 20', 23' and 27' outboard powered boats. We build boats using gelcoat, polyester resin, vinylester resin and acetone.

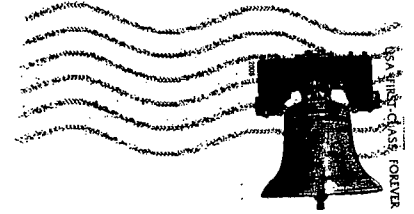
We have drastically reduced acetone usage by substituting AcraStrip to clean our brushes, guns and rollers. We use the Magnum Venus "fluid impingement" gelcoat and resin dispensing equipment to avoid eliminate atomization of these products.
