As per our conversation on Friday September 25th we, The Wheel Wizard, have determined that under the current Air rules, specifically Chapter 62-210 Stationary Sources – General Requirements subpart 61-210.300 we are exempt from needing our current General Air Permit for our facility located at 600 Sansbury Way, West Palm Beach, Florida.

The rules states the following:

- 27. Surface coating operations within a single facility, provided:
- a. The surface coating operation shall use only coatings containing 5.0 percent or less VOC, by volume, or the total quantity of coatings containing greater than 5.0 percent VOC, by volume, used at the facility shall not exceed 6.0 gallons per day, averaged monthly, where the quantity of coatings used includes all solvents and thinners used in the process or for cleanup; and
- b. Such operations are not subject to any unit-specific applicable requirement.

Our facility usage is well below these guidelines and therefore it is our formal request to rescind our General Air Permit (ARMS No. 0990688-001) due to our exemption from this rule.
