This is just a friendly reminder following our recent conversation of Friday, July 9, 2010 and our earlier conversation and subsequent e-mail on Friday, June 18, 2010 regarding the incomplete registration form submitted by Mr. Rob Brue on behalf of A-PLUS MASONRY & CONCRETE PUMPING LLC.

I will need all requested information no later than close of business, Thursday, July 15, 2010. If not received by then, I will have to deny A-PLUS MASONRY's entitlement to operate and I really don't want to have to do that.

To recap, on **Page 9** of the form I need a Description of Reasonable Precautions to be taken for fugitive dust emissions that may be over and above what has been checked in the check boxes.

On **Page 10** of the form, I need equipment details (process equipment as well emission control equipment) such as:

SILOS - How many & identify each

1. Name of Manufacturer of each
2. Model # of each
3. Capacity of each (in BBLs, Tons, or Cu.Yd.)
4. Product contained in each

DUST COLLECTORS, BAGHOUSES or VENT FILTERS

1. Attached to which equipment
2. Name of Manufacturer of each
3. Model # of each
4. Filter areas

BATCHER/MIXER & TRUCK LOADOUT

1. Identify any associated emission control measures or equipment associated with the process.

You can send all of the information requested via e-mail and I will simply attach your e-mail as an addendum to the current form.
