

Emissions from the silo loading operation are controlled by a Coneco Model PJ1400 Central Dust Collector. Emissions from the drop point of the weigh hopper are controlled by a Coneco BV-14 Dust Collector.

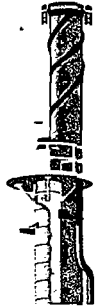
