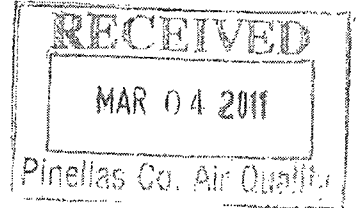

I bought the Highland dry cleaner located in 97 Highland Ave in Largo 33770. The previous owner did not guide me of any of the requirement required by the State or county I didn't know that I am in violation till one of the pinellas county officer visited the plant and told me about the requirement and guided me to how to apply and the steps needed for registration under new management. The previous owner was not doing dry clean for a long time . The dry clean machine have no Perchloroethylene in it. Since I took over Highland dry cleaner i did not use the dry clean machine and i did not do any dry clean for the customer and i will not be using it because i am not servicing any dry clean. I am only doing full service laundry, which is wash, dry, fold and steaming . I changed the name from HIGHLAND DRY CLEANERS to HIGHLAND CLEANER. The machine have no chemical in it and since i took over i did not even turn it on and i will not because i have no interest in dry cleaning. I did send a letter to the State to recind my license which i will send you a copy.

I am so sorry for any inconvenience that i cause to your department and officers. I hope you take my letter into consideration . Thank you for your time and effort for helping me and guiding me. Please call me if you have any question about my letter and if anything else i have to do I am sorry for what happened. I will be compliance with Pinellas County Department of Environmental and comply with the rules and regulation of what your management required.
