

As President of the corporation that owns Palms Cleaners, I have been registered for the Title V Air General Permit. 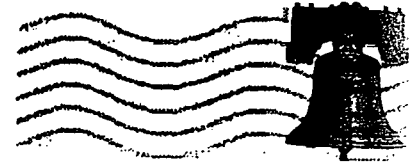
