The Department has received the Title V General Permit Notification Form for the dry cleaning facility that you submitted on August 19, 1998.



The facility lost its lease and ceased operation approximately two months ago. An inspection of the facility performed on 10/31/00, to verify shutdown, revealed that the dry-dry machine had been drained of perchloroethylene, removed and transported to Cleaners Equipment, Inc., a local dry cleaning machine maintenance company.

Therefore, the facility is deemed in compliance by shutdown. The Title V General Permit should be recinded.



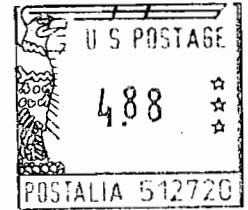


