Per your instructions I have attached to this letter a revised Air General Permit Registration Form for the Bartow, FL, Valmont Newmark, Inc. facility. I have attached only those pages whose contents were revised. The specific revisions are:

- 1. The reverse of the FDEP "reminder to register" letter is revised with the placement of a check in the "New Owner/Operator or Authorized Representative" box.
- 2. The Registration Type, "Re-Registration," has been revised with the addition of a check in the "Continue" operating the facility after a change of ownership" box.
- 3. Each appearance of "Newmark International, Inc." has been replaced by "Valmont Newmark, Inc." This establishes agreement with the new owner name which became effective March 8, 2008.

It is my understanding that the revised pages will be attached as an amendment to the permit registration form received by the FDEP on September 10, 2009. I further understand that this is an administrative correction and as such will not constitute a violation of the renewal deadline.
