The silo has a SV-170 Filter vent manufactured by Stevens Manufacturing.

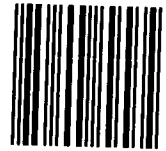

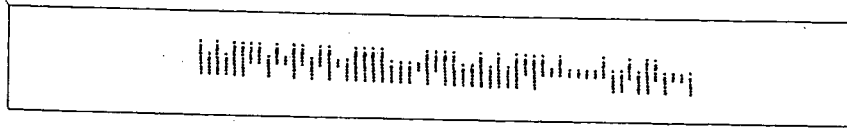
