Fugative emissions from the aggregate storage piles are controlled by water sprays as necessary. All conveyors and aggregate holding bins are totally enclosed. Fugative emissions from vehicular traffic are controlled sweeping or wetting as needed.

Description of Facility

This facility manufactures decorative patio and paver stones. The plant includes five silos with silo mounted Standley Batch System series 250 dust collectors and an aggregate handling system. The two 50 ton silos are not in production. At this time there are no plans to use these silos. If they are needed, the FDEP Southeast District office will be notified and the baghouses will be tested. The mixer and stone manufacturing are located inside the plant.

The Standley Dust Collectors have a collection efficiency of 99.9% at 755 ACFM and a cloth area of 252 sq. ft.

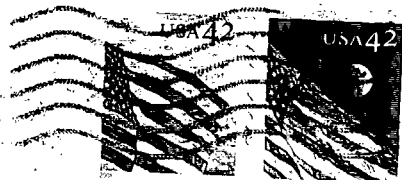
