



The facility will consist of an office, aggregate storage areas, 2 cement storage silo, concrete batch plant along with associated conveying equipment and concrete mixing trucks.

Emissions from the silo loading operation are controlled by a Model 30-250 dust collector mounted on top of each silo. Emissions from the drop point of the loadout area are controlled by a Model PJ-980 Dust Collector.

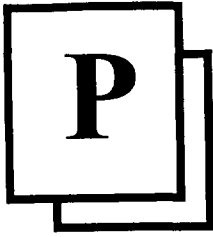
