The facility consists of an office, shop, aggregate storage areas, batch plant, storage silos, aggregate material conveying equipment and concrete mixing trucks.



The site has two storage silo. Each silo is equipped with a C.S. Johnson Model 250 baghouse dust collector. The cement weigh hopper and truck loadout emissions are controlled by a single central dust collector. The central dust collector is a C&W Dust Systems Model RA-120 baghouse.

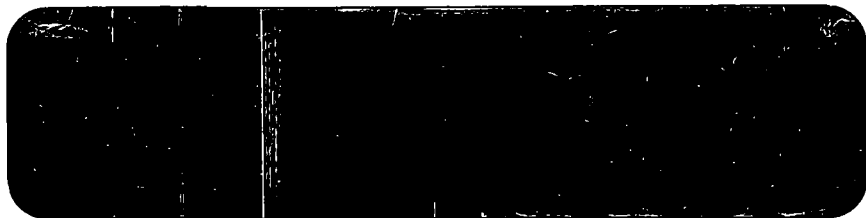

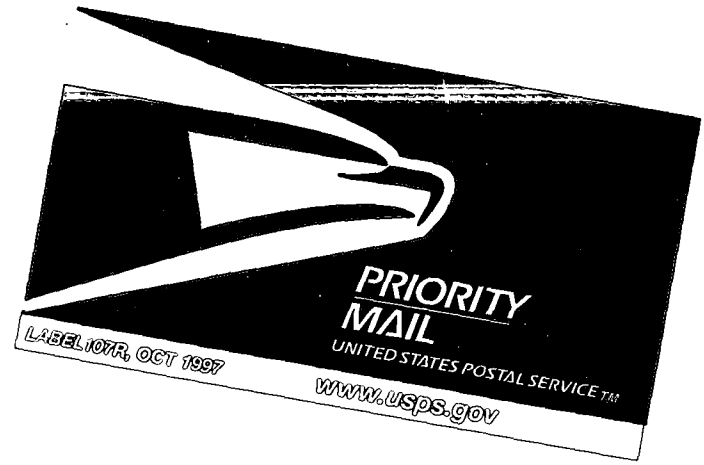
