
This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on September 11, 2008. We have assigned ARMS No. 1150025-005 to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty (30) days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after five (5) years. Therefore, a new registration form must be received no later than five (5) years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.



CEMEX Construction Materials Florida LLC. takes reasonable precautions to control unconfined emissions from hoppers, storage and conveying equipment, conveyor drop points, truck loading and unloading, roads, parking areas, stock piles and yards as required by Rule 62-296.320(4)(c), F.A.C. The following are the precautions taken at this facility.

Regular sweeping and/or the application of water to the yard is used to control airborne emissions.

Regular removal of particulate matter from roads, paved areas and work areas serves to reduce airborne particulate matter.

The height of stock piles are reduced to mitigate wind entrainment of particulate matter from the aggregates.

Description of Facility

Below, or as an attachment to this form, provide a description of the concrete batching plant operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. This facility consists of a ready mix concrete plant. This plant uses cement, flyash, slag and aggregate materials to produce ready mix concrete. Dust emissions are controlled by the following methods.

Emissions generated during the pneumatic filling of the silos are controlled by individual baghouses.

Emissions generated during the loading of mixer trucks are controlled by a C&W Model CP-900 dust collector.
