Good afternoon,

I do apologize for missing your call, but it's been one of those crazy Fridays.

As far as the description of the locations they are all as follows:

None have a paint booth since our spraying is done outside and involves only spot repairs. We have reviewed our procedures and even with the new EPA regulations coming in effect in 2011 we would still be allowed to continue as is since we spray from 3oz cups and therefore would not be governed by this new regulation. When it comes to our VOC usage we keep a daily log of our use and as described in our applications even estimating higher than our busiest days we are well below the allowed usage.

I hope this information is in line with what need and I apologize for not including a more detailed description in the applications.

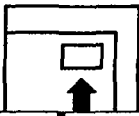

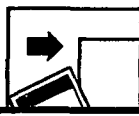

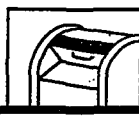
