

This facility operates a concrete batch plant with two storage silos, a weigh hopper and mixer load-out chute.

The southern most silo is split, one compartment contains flyash and one compartment contains cement. The northern most silo is also split, one compartment containing slag and the other containing cement.

Emissions from loading the two silos, weigh hopper and truck batching operations are all controlled by a single ground-mounted central dust collector. The central dust collector is a C&W Model CP-1220, serial number 1137.

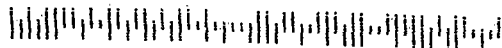
