This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on October 2, 2008. We have assigned ARMS No. <u>1270141-003</u> to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty (30) days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after five (5) years. Therefore, a new registration form must be received no later than five (5) years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.

Records in the Division of Air Resource Management indicate that you have claimed eligibility for your facility to operate under a Non-Title V Air General Permit (AGP) pursuant to Chapter 62-210, Florida Administrative Code (F.A.C.) and your entitlement to operate is about to expire.

As a source of air pollution, your facility is entitled to operate for no more than five (5) years with a AGP under Section § 403.0872 Florida Statutes (F.S.). Rule 62-210.310, F.A.C., establishes that the duration of the AGP is for five (5) years, and no later than thirty (30) days prior to the fifth anniversary of the filing of intent to use this AGP, the owner/operator or authorized representative shall submit a new notice of intent which shall contain all current information regarding the facility.
