THE CLEAR GELCOAT IS SPRAYED ON TO THE MOLDS IN A GRUBER MANUFACTURED SPRAY BOOTH WITH FIRE PROTECTION SYSTEM. THE BOOTH IS INSPECTED EVERY 6 MONTHS BY AUTHORITIES.
